The Dakota City City Council met in regular session on Wednesday, July 31, 2019. Moved by Backman, seconded by Rasmussen, to approve the consent agenda for July 31, 2019. Said motion includes approval of minutes from July 18, 2019, acknowledgement of reception of Financial Statements, and approval of Bills to Date as written including corrections. Said Resolution approves payment #46 in the amount of \$1,285.15 to JEO Consulting Group, Inc. for engineering services provided for the 2017 Wastewater Treatment Facility Improvement Project. Roll call vote: Voting Aye: Backman, Haase, Rasmussen, and Schovanec. Nays: None. Motion carried.

Moved by Backman, seconded by Haase, to approve Resolution 2019-31. Said Resolution approves the final payment application in the amount of \$33,645.00 to Rutjens Construction for work completed on the 2017 Wastewater Treatment Facility Improvement Project. Roll call vote: Voting Aye: Schovanec, Haase, Rasmussen, and Backman. Nays: None. Motion carried.

Ethan Joy, JEO Consulting Group, Inc., provided an update on the 2018 Street Improvement Project.

Moved by Schovanec, seconded by Rasmussen, to approve Resolution 2019-32. Said Resolution approves payment #19 in the amount of \$12,075.00 to JEO Consulting Group, Inc., for engineering services

provided for the 2018 Street Improvement Project. Roll call vote: Voting Aye: Haase, Rasmussen, Backman, and Schovanec. Nays: None. Motion carried.

Moved by Haase, seconded by Rasmussen, to approve Change Order #3 for the 2018 Street Improvement Project. The change order reduces the contracted amount with Sioux City Engineering by \$85,380.00 to account for an underrun of water system items no longer needed to complete the project. Roll call vote: Voting Aye: Rasmussen, Backman, Schovanec, and Haase. Nays: None. Motion carried.

Moved by Rasmussen, seconded by Backman, to approve Change Order #4 for the 2018 Street Improvement Project. The change order increases the contracted amount with Sioux City Engineering by \$54,181.50 to address unsuitable soil conditions found on Cedar Street. The City will forgo ten days of liquidated damages. Roll call vote: Voting Aye: Backman, Schovanec, Haase, and Rasmussen. Nays: None. Motion carried.

Moved by Backman, seconded by Schovanec, to approve Resolution 2019-33. Said Resolution approves Payment Application #8 in the amount of \$480,407.11 to Sioux City Engineering for work completed on the 2018 Street Improvement Project. Roll call vote: Voting Aye: Schovanec, Rasmussen, and Backman. Nays: Haase. Motion carried.

City Staff provided comments concerning City Departments, Current Projects, Ordinances, and Statutes.

The Mayor and Council Members provided comments concerning City Departments, Current Projects, Ordinances, and Statutes.

At 6:42 p.m. the Mayor recessed the Council Meeting and requested that the Council reconvene at the site of the 2018 Street Improvement Project. The Mayor and Council conducted a site visit of the 2018 Street Improvement project with city staff and the city engineer.
